Uranium Exploration

Eastern Athabasca

PurePoint Uranium Group Inc. will drill on its Turnor Lake Project in the Athabasca basin, and on the Red Willow Project which is between the operating McClean Lake and Rabbit Lake mines. They plan to drill 9-10,000 metres on the two projects over the winter. They will also carry out geophysical surveying on their McEwen, Umfreville and South Newnham properties near Black Lake in preparation for drilling next year. The company has raised \$7 million in financing to do the work and is looking for more properties to explore on its own or through joint ventures.

Consolidated Abaddon has joint ventured with International Uranium
Corporation (IUC) which will give IUC a 51% interest in Abaddon's Huard-Kirsch Lake properties, 15-20 km northwest of McArthur River. IUC must spent \$1.5 million by September 2008, and pay \$25,000 cash to earn the majority ownership. IUC plans detailed geophysical work this winter.

Abaddon has also joint ventured with Triex Minerals Corp. on its Mann Lake property, 25 km southwest of McArthur River mine and 15 km northeast of Cameco's Millennium Zone. Triex can earn up to 70% by spending \$3.5 million by March 2009. Triex will carry out detailed geophysical surveys over the winter, followed by a 5,000-metre followup drill program.

CanAlaska Ventures Ltd. is working on its West McArthur property, where they have identified new conductors in four areas. Ground geophysics will follow.

Canalaska has also optioned the 12,417-hectare Waterbury Project to Northwestern Minerals. Northweestern can earn up to 75% of the property by producing a feasibility study within two years, issuing shares to Canalaska and spending \$500,000 per year on exploration. Canalaska will remain the

operator until Northwestern has earned 60%.

Pitchstone Exploration Inc. spent the summer re-examining existing drill core, prospecting and boulder sampling on its Waterfound, Darby and Candle properties. Results will be analysed and duly reported.

A drill program was due to start on Waterfound in October.

Western Athabasca

COGEMA Resources Inc. and its joint venture partner UEX Corporation have spent \$7.5 million to date on the Western Athabasca projects. UEX has now earned the first 12.25% of the projects, on the way to the 49% maximum allowed in their option agreement. UEX plans to spend \$30 million over 11 years, earning 12.25% for every \$7.5 million spent. COGEMA remains the operator. UEX is a partner-ship of Cameco and Pioneer Metals.

The projects include the Shea Creek Project which includes the Anne and Colette deposits and the 63B Zone located between the two. Diamond drilling continued through September. Results from 63B showed average grades running up to 27.4% in some holes, including one significant intersection of 58.32% over 3.5 metres found in sandstone 30 metres above the unconformity Mineralization in this hole continues at up to 5.49% to 100 metres below the unconformity.

If the mineralization in the sandstone and the basement are connected, COGEMA feels this would represent a unique geological model for uranium mineralization not found at existing mines.

Results from the Colette area indicated an average grade of up to 2.27% uranium.

Triex Minerals Corp. will drill this winter on its **West Carswell** property, located northwest of the Shea Creek deposit.

Northern Athabasca

CanAlaska Ventures Ltd. has been working on its 490,340-acre North East Athabasca Project, which straddles the Saskatchewan-Manitoba border. They think the area was once covered by Athabasca sandstone, which may lead to similar uranium deposits as those occurring under the sandstone farther west. This summer, Canalaska did detailed lake sediment sampling on the entire licence area, ad is completing surface followup and sampling using 15 geologists and prospectors. So far 14 zones of interest have been found, seven of which were previously explored. Preliminary values up to 0.81% U3O8 have been found.

CanAlaska Ventures Ltd. is continuing work on its Helmer and Lake
